# **Kentucky Section AIPG Business Meeting**

Saturday, May 12, 2018

#### Welcome and Call to Order

The meeting was called to order at 10:10 a.m. by President-Elect Donnie Lumm (President Trent Garrison was a late arrival to this meeting).

#### **President Elect's Report**

President Elect Donnie Lumm mentioned that the primary purpose of today's Executive Committee meeting was to review the logistics and procedure for the KY-AIPG awards that would be presented by Trent Garrison during the lunch period at the Kentucky Geological Survey's (KGS) Annul Meeting scheduled for Friday, May 18, 2018. Donnie also mentioned that the technical workshop co-sponsored by the Geological Society of Kentucky (GSK) and KY-AIPG on limestone core description that was planned for May 25, 2018 had been postponed until the Fall 2018. The date for the event will be announced later.

## **Treasurer's Report**

Treasurer Bill Brab distributed a copy of the Treasurer's Report dated April 30, 2018. Bill reviewed the Report, and a summary of this Report is listed below.

According to personal communication from Tim, the Minutes were approved with minor corrections on May 11, 2018.

# **Vice President's Report**

Vice President Edward Lo discussed his recent outreach efforts to arrange for an informal mineral display at the "Indigenous Peoples' Day" sponsored by the Kentucky Native American Heritage Commission and which is scheduled for June 9-10, 2018 at the First Street Park in Shepherdsville, KY. Edward asked for ideas or ways to contribute to the outreach event. Edward also reported that he has been in contact with Mr. Steven Russo, Director of the East Kentucky Science Center and Planetarium in Prestonsburg, KY. Edward mentioned that the Science Center does not have a geoscience exhibit, and that there is a need to

have one. Edward has been in contact with Ann Harris, an adjunct professor at Eastern Kentucky University (EKU) for help in this outreach effort.

Edward also said that Mitchell Clary was chosen or elected to be the Graduate Student Representative for the Department of Earth and Environmental Sciences at the University of Kentucky (UK).

#### **President's Report**

President Trent Garrison, who had arrived at the meeting, mentioned that he attended the recent retirement party for Northern Kentucky University (NKU) Professor John Rockaway. Dr. Rockaway is a longtime member of AIPG and supported many student outreach functions and gatherings of KY-AIPG at the Highland Heights, KY campus for many years.

Trent gave a short PowerPoint presentation regarding the KY-AIPG Awards that he will present at the KGS Annual Meeting on May 18. Trent showed a slide listing the purpose and recent outreach events of KY-AIPG, and photographs of the students who would be receiving the Student Scholarship awards. These students are Roger Olson (NKU), Madison Hood (UK), and Katherine Loosekamp (Murray State University). Trent mentioned that he would follow the Student Awards with awards and plaques to Past President Mark Sweet, Geologist of the Year to Gary Stinchcomb (Murray State University), and the Lifetime Achievement Award to John Beam (Stantec).

Larry mentioned that he received the names of three (3) nominees from Richard Smath for the Kentucky Geographic Information System (GIS) advisory position which were requested by and submitted to Governor Matt Bevins' office for consideration. Four or five field trip stops are planned to examine the Grant Lake Formation and other Richmondian (Late Ordovician) strata in the area. The Maysville area is well known for classic exposures of various invertebrate fossils.
